Vide memo under reference, your office has informed that 3 acres land adjoining to the existing site of Govt. College for Women, Sector-14, Panchkula has been earmarked for the college and further informed that 3+3.5 acres of land is available in the college premises for planning of the various sports fields.

In this regard, after going through the enclosures received along with your letter under reference, it is found that total 13.13 acres (7.06+3.00+3.07) of land has been allotted to Govt. College, Sector-14, Panchkula. Initially 7.06 acres of land was allotted for construction of Govt. College for Women, Sector-14, Panchkula and Zoning Plan of the same was received in this office for preparation of architectural drawings. Later on 3.00+3.07=6.07 acres land has been allotted to the college for its expansion.

Further necessary action shall be taken after receipt of composite Zoning Plan of the college campus.
